

## Instructions for Completing Form I-9 Employment Verification Remotely

Federal law requires University Enterprises, Inc. (UEI) to have a valid Form I-9 on file for every employee. Form I-9 has two sections: Section 1 is completed and signed by the employee, and Section 2 is completed and signed by the employer (or authorized representative) after examining the employee's original documents (see list of acceptable documents). Federal law requires the employee to complete Section 1 no later than their first day of employment and Section 2 of the form I-9 no later than three business days from their employment start date.

Due to COVID 19 our offices are currently closed to the public, so we are unable to serve employees or clients in person. Employees working outside of the greater Sacramento area are expected to complete their paperwork with the assistance of their supervisor or department designee, HR professionals at nearby organizations, local librarians, attorneys or accountants, state workforce agency staff, or notaries. Below are detailed instructions for completing Form I-9 remotely.

### Process for Completing the Form I-9 at a remote location

1. The employee completes Section 1 (found with the new hire/rehire orientation packet sent via secure file transfer email) by the first day of employment, either before visiting a designated representative or in the presence of the designated representative. You will need to take the Form I-9 and your document(s) from the List of Acceptable Documents to the designated representative to complete Section 2. The designated representative can be your supervisor at the location where you will be working, HR professionals at nearby organizations, local librarian, attorney, accountant, state workforce agency staff, notary, or you can call Patricia Lau at UEI Human Resources to locate another university or auxiliary in your area where you can complete Section 2.
2. When you visit the designated representative, please provide them with your instructions for completing Section 2 (found on page 2). If they have questions or concerns, they should call the contact number listed on the instructions.
3. Please send the completed I-9 Form and a copy of the documents you presented to the representative via the secure file transfer email that you received that included your orientation documents. You can also send the original I-9 Form (not a photocopy) and a copy of the documents you presented to the representative. These must be postmarked no later than three days from your employment start date. Please mail the necessary information to:

## Instructions for Designated Representative Completing Section 2 of the Form I-9

Thank you for completing Section 2 of the Form I-9 Employment Authorization on behalf of University Enterprises, Inc. (UEI). Please follow these steps to complete the form accurately and completely. You may also refer to the [United States Citizenship and Immigration Services I-9 Central](#) for additional information and resources.

1. The University Enterprises, Inc. employee will present to you the Form I-9 with Section 1 already completed or they may complete Section 1 in your presence.
2. Please complete Section 2 on the second page of the form. We have prepopulated the employer name and address for your convenience.
3. Examine the documents presented by the employee from either List A or from Lists B and C of the List of Acceptable Documents. Please note: the documents presented must be the original and unexpired documents. You may not accept a picture, photocopy video, etc. of the List A or List B or C documents. If the employee does not have original document(s), they will need to return with them to complete the form.
4. Please fill in the required information and make a legible copy of the documents that were presented to you.
5. **Notary Publics:** Please do not stamp the Form I-9 with your seal. You are completing Section 2 on behalf of University Enterprises, Inc. and acting as one of our authorized representatives, not as a notary.
